Pupil Premium Overview 2014-15

In 2011/12 the Government launched its Pupil Premium funding initiative. This money is sent to schools based on the numbers of children who are either eligible for Free School Meals (FSM) or are Looked After Children (LAC). From 2012/13 it has been expanded to include all children who have been eligible for FSM within the last 6 years. The Pupil Premium funding that is received by the school annually is used in a variety of ways in order to improve pupil attainment and to help overcome any barriers to learning.

Focus of PPG spending 2014/15	Aim
Curriculum Enrichment	To enhance the curriculum and maximise pupils' engagement and enjoyment of topics covered.
One to One Tuition	To help pupils reach their full potential in Mathematics and Literacy.
Funding places on school trips	To enhance the curriculum, ensure the pupils are able to participate and to give children an opportunity to experience new and challenging activities.
Mentoring	To support pupils' self esteem, attitudes to learning, sense of well-being and enjoyment of school, via 1:1 sessions.
Funding After-School Club activities, trips, inter school sport and residential.	To ensure pupils are able to participate and to give children the opportunity to experience new and challenging activities both in and outside of school.
School Uniform Support	To ensure the children are able to attend school in appropriate clothing.

Impact of PPG spending 2014/15

How do Free School Meals (FSM) or Looked After Children (LAC) pupils do at Hanbury C.E. First School?

In 2014/2015 FSM/Ever 6 children performed equally to non FSM in some areas. Whole school attendance is above target (95%) at 95.4% in 2014/15, with the attendance of the school's FSM pupils averaging 93%.

	FSM	Non FSM
Reading	100%	100%
Writing	50%	60%
Spelling, Punctuation and Grammar	0%	25%
Maths	0%	50%

- 100% of pupils eligible for FSM achieved Secure in Reading by end of Year 4
- 50% of FSM children were secure in Writing by the end of Year 4.
- In Spelling/Grammar FSM pupils did not achieve Secure against 25% for non- FSM.
- In Maths FSM pupils did not achieve Secure against 50% for non- FSM.

The school judges the impact of the Pupil Premium support in 2013-14 at Key Stage 2 to be good

	Percentage of pupils achieving 2b and above at end of Key Stage 1 (Year 2)

Writing	60%	89%
Maths	60%	78%

End of Key Stage 1 pupils 2013/14 :

- 80% of FSM pupils achieved 2B or above and 20% Level 3 in Reading
- 60% of FSM pupils achieved 2B or above and 0% Level 3 in Writing
- 60% of FSM pupils achieved 2B or above and 0% Level 3 in Maths

The school judges the impact of the Pupil Premium support in 2014-15 at Key Stage 1 to be Good.

Measuring the impact of PPG spending 2015/16
